

The cases attached are set for trial from **March 6 to March 16, 2012**. The list of cases does not reflect the order of the trials. The order of trials is to be set at Jury Selection.

The cases listed below are **also** set for Call of the Docket on **March 5, 2012**. You will receive separate notice for when your case will be called for the March 5th date.

Jury Selection will be on **March 6th, 2012 at 8:00 a.m.** Counsel and defendants **MUST be present** and be prepared to spend the entire day in court.

The State shall make a good faith plea offer to each Defendant by February 24, 2012 (unless a defendant has unequivocally stated he/she is not interested in receiving an offer). Each defendant shall respond to the offer no later than March 2, 2012.

Any requests for protection shall be filed by **March 2, 2012**.

Counsel are reminded that defendants are required to pay all assessments and surcharges at time of sentence. A substantial down payment is due on all fines not paid in full. In cases where driver's license is suspended, license must be presented to the clerk. Stays of execution of sentences will be considered on in cases of extreme emergency.

All parties are reminded that contact of any kind with jurors is prohibited until jurors are finally discharged from jury service.

NO negotiated plea agreements will be considered after a jury has been selected (barring extraordinary circumstances).
